Reconstruction of Wastewater Pumping Stations and the Main Switching Chamber of Pressure Wastewater Collectors in the City of Lutsk, Volyn Region

(LUT_WW_1)

This Invitation for Tenders follows the General Procurement Notice dated 21 August 2025 for the Programme “Rehabilitation of wastewater services in four cities of Ukraine: Horishni Plavni, Lubny, Lutsk, Khmelnytskyi” which was published on the Procurement Notices section of NEFCO’s website (<https://www.nefco.int>).

Municipal Utility Company “Lutskvodokanal”, hereinafter referred to as “the Employer”, intends to use the part of the proceeds of grant financing from the Impact Fund Denmark (formerly Danida Sustainable Infrastructure Finance) (hereinafter referred to as the Impact Fund Denmark) through the fund manager the Nordic Environment Finance Corporation (NEFCO) towards the cost of the project “**Reconstruction of wastewater pumping stations (WWPS) and installation of solar power panels (SPP) in Lutsk city in Ukraine**”.

The Contracts under the Programme shall be financed by a grant from the Impact Fund Denmark and by the municipal budget and/or the Employer.

The Employer now invites sealed tenders from Contractors for the following contract LUT_WW_1 “**Reconstruction of Wastewater Pumping Stations and the Main Switching Chamber of Pressure Wastewater Collectors in the City of Lutsk, Volyn Region (Lot 1: Reconstruction of Wastewater Pumping Station (WWPS) No. 1 at 2 Heroiv UPA Street, Lutsk, Volyn Region; Lot 2: Reconstruction of Wastewater Pumping Station (WWPS) No. 2 at 8 Naberezhna Street, Lutsk, Volyn Region; Lot 3: Reconstruction of the main switching chamber of pressure wastewater collectors on Heroiv UPA Street, Lutsk, Volyn Region Lot 4: Expansion and upgrade of the existing ACS and SCADA)**” to be financed by the Impact Fund Denmark grant.

Tenders and subsequent contracts financed by the grant funds shall be carried out in accordance with NEFCO’s Procurement Policy and Procedures.

The proceeds of the Grant shall not be used for payment to persons or entities or for any import of goods, if such payment or import is prohibited by a decision of the United Nations Security Council taken under the Chapter VII of the Charter of the United Nations or pursuant to the laws or official regulations of Ukraine.

Tenders are invited for the full scope of work. Tenders submitted only for a part of the works (separate lot(s)) will be rejected.

Based on the results of the Tender, the Employer shall sign Contract LUT_WW_1 with the Tenderer, that submits the most economically attractive tender and meets all qualification requirements.

Tenders shall be priced in Euro.

The Contract LUT_WW_1, financed by the Impact Fund Denmark grant, shall be tax exempt in accordance with Resolution of the Cabinet of Ministers of Ukraine dated 15.02.2002 No.153.

To be qualified for the award of the contract, tenderers must satisfy the following minimum criteria:

Tenderers shall meet the eligibility requirements outlined in the Instructions to Tenderers.

- The Average Annual Turnover over the **last four (4) years (2021-2024)** exceeded **EUR 1,200,000** equivalent; In case of tender submitted by JVCA, the leading partner shall demonstrate at least 50% compliance with the requirement.
- The Tenderer has satisfactorily supplied and completed for the **period 2020-2024**:
 - **three (3) similar contracts** as the main contractor, which have been fully and satisfactorily completed and are similar to the proposed equipment and works, with a total value of not less than **EUR 1,200,000** and
 - at least **one (1) contract** covering the installation of a SCADA system.

In case of tender submitted by JVCA, the leading partner shall demonstrate at least 50% of the above-mentioned requirement and the JVCA partner - at least one (1) contract according to this criterion.

- Non-performance of contract by the Tenderer (including partners/members of JVCA if appropriate) did not occur **during the last 3 years (2022-2024)** based on information provided in Section III, Tender Forms (the Employer reserves the right to check the correctness of the reported information by using other sources);
- All pending litigations against the Tenderer (including, where applicable partners/members of JVCA) shall not, in total, represent **more than 30%** of the Tenderer's net worth;
- The Tenderer (whether a single legal entity, a JVCA partner or a designated subcontractor) shall demonstrate availability of all personnel for the implementation of all necessary works under the Contract;
- The Tenderer shall demonstrate that it has the personnel for the key positions that meet the Qualification requirements outlined in the Tender document.

The Employer reserves the right to cancel all tenders in the event of non-approval of grant funding.

During the preparation of tender the Tenderers shall take into account that the works under this Contract shall tentatively start in **January 2026** and be completed no later than **in March 2027**.

Tender documents shall be obtained from the office at the address below, free of charge, upon a written request from a prospective Tenderer.

Upon receiving the written request from prospective Tenderer, the documents shall be promptly dispatched electronically in PDF and MS Word format, however, no liability shall be accepted by the sender for their non-delivery or late delivery. In case of discrepancies between the PDF and Word versions of the documents, the PDF version shall prevail.

All tenders shall be accompanied by a Tender-Securing Declaration. The form of Tender-Securing Declaration is provided in the Tender document. The main purpose of Tender-Securing Declaration is to ensure that the tenderers are serious about their participation.

Tenders shall be received no later than **14:00 (Kyiv time) on 2 December 2025** at the address indicated below. They shall thereafter be opened in the presence of those representatives of the Tenderers who choose to attend the opening.

A pre-tender meeting for Tenderers with Employer representatives to discuss technical and procedural issues shall take place online at **13:00 (Kyiv time), 23.10.2025**.
